You are hereby notified that the 87th Annual Meeting of the Members of Calhoun County Electric Cooperative Association will be held at the **Calhoun County Electric Cooperative Association Headquarters in Rockwell City, Iowa** beginning at 5:00 p.m. until 6:30 p.m., with a short, business meeting to follow on Thursday, September 7, 2023, to take action upon the following matters:

- 1. The reports of officers, directors and committees;
- 2. The election of three (3) directors of the Cooperative for a term of three years each;
- 3. All other business, which may legally come before the Meeting or any adjournment or adjournments, thereof.

CCECA Directors Vote to Return \$188,519 Back to Members

At their June board meeting, the Calhoun County Electric Cooperative Association (CCECA) Board of Directors authorized more than \$188,000 in capital credits to be returned as bill credits on members' July electric statements.

"This action is a result of CCECA's strong financial performance, financial stability, and returning value to the membership," said Board President Jim Miller. "It's a testament to CCECA's commitment to the cooperative principles and local governance structure."

Each year CCECA strives to return allocated capital credits within a 17-year schedule. With this distribution, all capital credits through the year 2006 will have been retired. The Board has also approved the return of a portion of the most recently allocated capital credits back to current members. Members with patronage in 2022 will receive a bill credit, as well.

"Over the course of just the past five years, the CCECA board has approved the distribution of

over \$1,000,000 in capital credits," said Keaton Hildreth, CCECA CEO. "One of the benefits of being a member of a cooperative is that members own their cooperative, and therefore are entitled to the retirement of previously allocated margins, or profit. We assign all operating and non-operating margins to our members on a patronage basis, and the board at its discretion may decide when to retire those margins that were allocated in prior years."

This action will bring the amount returned to members since the year 2000 to over \$3,000,000 via capital credit retirements and bill credits.

Hildreth said current members will receive a bill credit for their share of the patronage capital credit retirement, which is determined based on their power purchases during 2006 and 2022. The bill credit will appear on members' July 2023 electric bill that will be issued in August. Members no longer receiving service from CCECA will be issued a check.

Energy Efficiency Tip of the Month

Did you know ceiling fans can make a room feel 4 degrees cooler? To save energy through to raise your thermostat a few degrees while fans are turned on. Ceiling fans can help improve comfort vear-round. In the summer, operate ceiling fans in a counterclockwise direction. Reverse the direction to clockwise during winter months and can circulate from the ceiling to the lower levels of the room.

Remember, ceiling fans cool people, not spaces. Be sure to turn them off when you leave the room.





AIR FRYER STEAK BITES

INGREDIENTS:

- 1.5 lbs steak use your favorite cut such as sirloin, New York, or ribeye, cut into 1 inch bite-sized pieces
- 2 Tablespoons unsalted butter melted
- 2 teaspoons Worcestershire sauce
- 2 teaspoons Montreal steak seasoning
- 1 teaspoon garlic powder
- 1 teaspoon dried Italian seasoning
- 1 Tablespoon fresh chopped parsley for garnish

INSTRUCTIONS:

PREHEAT AIR FRYER:

1. Set the air fryer to the air fryer setting at 400F degrees to preheat.

PREP STEAK:

- 1. Toss the diced steak pieces with melted butter and seasonings.
- 2. Spread the steak pieces evenly in your air fryer basket (depending on the size of your fryer you may need to cook in two batches).

AIR FRY:

1. Air fry at 400F for 14-16 minutes or until your steak bites are cooked through.

TO FINISH

1. Garnish with fresh chopped parsley and serve with mashed potatoes or your favorite veggies, enjoy!

Note: *Store leftovers in an airtight container in the fridge for up to 3 days.*
