# HAPPY RETUREMENT



2017 and is installed at our headquarters located in Rockwell City. This solar array is a 76 kW AC system. Our purpose for doing this demonstration project was to learn more about how solar generation performs and how generation times compare to our peak usage times for our members. For the past 5 years, our solar array has produced approximately 692,156 kWhs. So far, 2022 has been the best year for solar production with 103,720 kWhs being produced from January 1 to August 31. More of our members have been contacted by renewable vendors and have considered installing a system of their own. If you are considering installing a renewable system please give us a call and we will help answer any questions you may have as well as share information from our demonstration project. Is your home heating system ready for the winter chill? One of the easiest ways to keep your system running efficiently is to regularly replace filters. If your central air system has a furnace filter, it should be replaced about every 90 days.

If your home is heated through warmair registers, baseboard heaters or radiators, remember to clean them regularly to boost efficiency.

# GROUND BEEF STROGANOFF



## **INGREDIENTS:**

- 1 TB Olive Oil
- 1 lb ground beef
- <sup>1</sup>/<sub>2</sub> onion, diced
- 1 lb mushrooms, sliced
- 1 TB minced garlic
- 3 TB all-purpose flour
- 1 cup beef broth
- 1 cup heavy cream
- 3 TB Worcestershire sauce
- <sup>1</sup>/<sub>2</sub> cup sour cream
- ½ tsp salt
- ½ tsp pepper

## **DIRECTIONS:**

- 1. In a large cast iron or regular skillet, drizzle the oil and turn heat to medium high. Add ground beef and cook until browned. Add the diced onion and garlic. Stir and cook for another 3 minutes.
- 2. Add the mushrooms to the skillet and stir together then sauté for 5 minutes until mushrooms get soft.
- 3. Add the flour to the beef mixture and stir together. Add the beef broth, heavy cream, Worcestershire, salt and pepper. Stir together and turn heat to low. Simmer for another 5-7 minutes until mixture gets thicker.
- 4. Remove from heat and stir in the sour cream.
- 5. Serve over egg noodles or rice.

## Take advantage of LIHEAP to help with heating bills

The 2022-2023 Low-income Home Energy Assistance Program (LIHEAP) has been established to help qualifying low-income Iowa homeowners and renters pay for a portion of their primary heating cost for the winter heating season. The assistance is based on household income, household size, type of fuel, and type of housing. #### WHEN TO APPLY:

- Elderly (60 & over) and/or disabled: October 1, 2022 to April 30, 2023
- All other households: November 1, 2022 to April 30, 2023

## WHAT TO TAKE:

- **Proof of Income** (for all household members age 19 and over) Depending upon your household income type, income documentation from the past 30 days, the last 12 months, or last calendar year, whichever is easier or more beneficial for you.
- Proof of Social Security Numbers for <u>ALL</u> household members (documentation required)
- Most recent heat bill
- Most recent electric bill

For family units with more than eight members, add \$9,440 for each additional member.

## WAGE EARNERS:

Please bring copies of your check stubs for the 30-day period preceding the date of application, or a copy of your most recent federal income tax return.

## **FIXED INCOME:**

This income may include: Social Security Benefits, Supplemental Security Income, Veteran's Assistance, Unemployment Insurance, and pensions. Please bring copies of your check stubs from the previous 30 days.

#### **SELF-EMPLOYED/FARMERS:**

Please bring a copy of your most recent federal income tax return.

If you receive alimony or child support, it will also need to be verified. Additional income not listed here may be required.
